#### Supervision Philosophy

Susan Myket, Ph.D. & Associates follows the supervision requirements for obtaining an Illinois Clinical Psychologist License and works with each school to meet their program-specific supervision requirements. Weekly supervision is provided by a licensed clinical psychologist. Our practice also provides a weekly group supervision and didactic training, which is an opportunity for all clinicians to continue to grow their clinical skills and share knowledge with one another. We may provide more than one supervisor over the course of the year, so the student can learn how to treat from a variety of perspectives. Our supervision philosophy is collaborative. We review each intake client and collaborate on a treatment plan, with the student taking the lead and seeking support and advice on adjustments to the plan as appropriate throughout a client's care. Once the student has an established client load, supervision will be spent doing a guick check-in on each client as needed and then the student will bring challenging/growth cases or issues to discuss. We have an open-door policy and encourage students to seek in-the-moment advice from any of our clinicians in the practice who may have expertise on a certain concern or type of client. We also provide our students supervision & training on insurance coding and the financial aspects of a private practice.
